

PRIZE DISTRIBUTION.

The Annual Prize Distribution was held in the Big School, on Thursday, December 17th, and was of a semi-private nature for reasons explained by the Headmaster in his report. The Mayoress distributed the prizes, and among those on the platform were Colonel Stallard, who presided, the Mayor (Ald. A. H. Leicester), the Rev. G. F. Hooper, Ald. G. W. Grosvenor, Messrs. F. A. Simes, R. R. Fairbairn and F. Hyde.

The Headmaster said that the advisability, even the propriety, of holding a prize-giving this year was a point on which each of them would probably give a different opinion. They had therefore compounded with a semi-private meeting in their Old Hall. He could promise that that would be the last prize-giving in the Old Hall. The New Hall was now very near completion, but the opening ceremony would not be immediately. One would like to see the crisis in the Empire's affairs nearer to a happy termination before entering on the rejoicing on so great an addition to the School. That Old Hall had been the cradle of the modern School. It was built in '68. In the early days of Mr. Eld it was hall and classroom-or rather, classrooms, and, at times, playground, too. It had seen and heard many of the greatest successes of the School. It was very pleasant to see the Mayor and Mayoress there. It was just nine years since they left that Old Hall for their prize-givings in the Guildhall. Ald. and Mrs. Leicester were then the first to come to them at the Guildhall. Now they saw the Old Hall out, and there was little doubt that they would, as Mayor and Mayoress, see the New Hall in. Up to the end of the Summer Term their numbers were normal, but in common with most other schools they had felt the call of the war at the top of the School. After reading the list of the scholarships obtained during the year, Mr. Hillard said that there was one point about all these scholarships which was worthy of notethe extreme youth of the winners. The successes of these boys could not be put down to premature specialisation. They had just walked out of the ordinary form rooms, concentrated on one group of subjects for little more than a year, and then taken some of the best scholarships at the Universities. He did not know what parents thought, but any schoolmaster knew that it showed that the general curriculum of the school was thoroughly sound and of a high standard. The games of the School had also been in a very flourishing condition. Even the smallest boy in the Preparatory School was sure of his regular games with equal companions and under proper supervision. Juvenile matches with outside Preparatory Schools had become a feature, and Mr. Chessall's problem was more often to get a weak enough team rather than a strong one. The 1st XI. had been particularly good, and had

not lost a match this Term. He specially commended the Captain, Howes, who had really worked hard and with success to render his team good. Since the war broke out attention had been largely concentrated on the O.T.C. The Corps was over a hundred strong, and those who had passed through the Corps in former years were reaping the advantage, and so was the country. The O.T.C. had at different times come in for much criticism. We had been told we were encouraging the military spirit-schools did not exist to turn boys into soldiers—the Germans were a peaceful nation, and it was ridiculous to think we should have to fight. We had over 200 boys in the Army, and most of them had been through the Corps, and a large number already held commissions. The man responsible for that was Captain Dippie. (Applause). He came here specially to do this work, and excellently had he done it. He had hung on until the Corps was in other hands, but he was sorry to say that he was going at Christmas. Every member of the School would wish him active work, much honour and promotion, and a safe return to his friends. While most inadequately acknowledging his gratitude to the Governors, especially to Colonel Stallard and Mr. Hyde, he must also put in a special word of thanks to Mr. Hooper. Mr. Hooper had for many years been unofficial, and unremunerated Chaplain to the School House, where his influence and kindly personality had been of inestimable benefit. To add further to his kindness, during the Spring and Summer Terms he had taken charge of some of the Divinity classes, and to those who knew Mr. Hooper it would be known that the boys would gain much from his teaching. Thanking the Staff, the Headmaster also expressed thanks to the Governors for giving him such long leave of absence because of ill-health. It was all the more creditable to the Staff that they had carried on the work of the School just in the ordinary way, according to the traditions of the School, so that he thought no one had suffered at all through his absence. (Applause). He especially wished to recognise his debt to Mr. Carter-(applause)-and the debt of the Governors and parents also. He had not only carried on his own work just as usual, but he had added to that the work of acting Headmaster. In conclusion, Mr. Hillard said that the new building would be an enormous advantage to the boys, especially those from the county.

Mr. Grosvenor proposed a vote of thanks to the Mayor and Mayoress for attending, the Mayoress especially for giving away the prizes. They all knew, he said, how for so many years Mr. and Mrs. Leicester had striven for the good of the community in Worcester, and especially, those who were connected with that School knew the kindly interest Ald. Leicester had taken in its welfare. He offered his personal congratulations to the Headmaster on his return to the School and his improved health. His forceful personality and organising ability were great assets to the School. They were fortunate in having had so successful a substitute in Mr. Carter. It gave him great gratification to see the O.T.C. so well carried on.

Mr. Simes, seconding, confessed that he felt miserable at being present at the obsequies of that dear old hall. He was, he believed, the only one on that platform who preserved both pleasant and unpleasant memories of that hall. Colonel Stallard, whose recollections went back further, only saw it on state occasions. (Laughter). They did recognise in Worcester that, before the beginning of the war, and particularly since the outbreak of war, Alderman and Mrs. Leicester had had always in view what could be done to help the citizens in this trying time. "From early morn till dewy eve" the Mayor not only worked himself, but made other people work also, and he was most ably seconded by Mrs. Leicester. (Applause).

In reply, the Mayor recalled that their prize-giving was one of his earliest public functions as Mayor, and that had caused him to take a keener interest in education, and stimulated him to make himself eligible as a Governor. He urged the boys to beware of the dangers of specialising in certain subjects to the detriment of others. Booklearning, too, must be backed up by higher things, or they might be charged in the future with being "a cultured nation."

Cheers were given by the boys for the Mayor and Mayoress, the Governors, Headmaster, Staff and Visitors.

HOCKEY.

THE LEAGUE.

This year the League Competition took the form of a six-a-side Tournament. The games were keenly contested, and the scores, in most cases, were low. The time allowed for each game was half-an-hour, which proved quite enough for most players.

School House being heavier and faster than their opponents, had little difficulty in winning all their matches. Jackson, Beynon and Watson were always prominent, and Church proved very useful in front of goal.

Temple and Yewle tied for second place, each winning three times. For the former, Roberts, Morrall and Wasley did good work, while Gibbs, Heath and Thomas, A. played well for Yewle.

Tudor came next. They have several promising players, and it is surprising that better results were not obtained. Fudger played well at back, and Davies, H. J. has improved.

Woolfe, fifth, and Wylde met with little success. In both cases, the teams failed to work together and were weak in front of goal.

THE CHALLENGE SHIELD.

In the First Round, School House defeated Woolfe in a very one-sided game. However, the tie between Tudor and Temple proved more exciting. Temple opened the scoring and obtained four goals before their opponents found the net. Shortly after half-time Tudor drew level, but Temple replied with two more goals. When time was called the score was six all. Extra time proved too much for Temple, and their opponents qualified for the next round by adding three more goals.

In the Second Round, School House again had an easy task and defeated Wylde by seven goals. A good game between Tudor and Yewle resulted in a victory for the former

The Final, between School House and Tudor, was an even game up to half-time, but the superior weight and pace of the School House team began to tell, and they eventually won the Shield by a comfortable margin.

CROSS-COUNTRY RACES.

These events took place on March 20th, in fine weather. The course was the usual one and the ground was dry. Two or three trial runs had been arranged on previous half-holidays, but they were not well attended.

There were only 17 starters for the Senior Race, all of whom finished. Crickmer took the lead in the early stages, followed by Maund, Johnson and George. But on reaching Coneybury Wood Johnson forged ahead, with George second. This order was maintained until the last field was entered. Here George caught up with Johnson, who was running very well. During the last 20 yards George managed to establish a lead and won a good race in 25 minutes 57 seconds. Crickmer finished third, followed at some distance by Maund, with Burston on his heels. The sixth place was obtained by Thomas, C. G., a long way behind.

The Juniors, who numbered 23 runners, started off with Arnold and Dowty, G. H. taking the lead. Shortly after this, Wheal, C. W. W. drew up and challenged Arnold, but was unable to overtake him. An excellent finish followed: Wheal overtook Arnold, who was somewhat exhausted, in the last 15 yards, and won in 18 minutes 54 secs. Dowty, E. F. was a good third, and Armstrong, G. N. and Greenway, J. K. followed at short intervals. Adams, who ran very well, was sixth.

We are glad to welcome a new officer in 2nd. Lieutenant H. H. Abbott, who has been appointed for service with our contingent.

Twelve members of the Corps left us last Term. We regret their departure, and extend a glad welcome to this Term's recruits, who number thirteen.

The Term has been a busy one, the most important event of course, being the visit of Hon. Brigadier-General Townley. The notice of his coming was rather sudden, and consequently our preparation was a little feverish, since so many of us had not before experienced the terrors of an inspection. However,

beyond our being unable to adopt a formation used in savage warfare, all passed off well. Several half-holidays have been used for Corps work. We have fought our way across Hindlip Park, against a stout opposition offered by Sergt. Wedge and his "skeleton" army. Elbury Hill was stormed regardless of loss on another occasion. This time the "enemy" was disorganised. A route march was made towards Crowle on February 20th, the return being made through Spetchley. On another day Sergt. Day made a vigorous attempt to prevent a stronger force from blowing up an important railway bridge. Much keenness and lively interest was shown on this occasion. The attacking forces acted in complete concert, while the defensive force carried out an orderly retirement. We hope the coming "Corps days" will be as happy as this last.

Next term must needs be a strenuous one as far as the Corps is concerned. Good progress has been made with arm drill, but much practice will be needed to obtain a good standard in company and extended order drill. Much time will be needed, too, for the musketry courses; but with the opening of the new armoury and range much of our work will be facilitated. We can count on the N.C.O.'s doing their share next Term. If the remaining members of the Corps will be content to obey the orders of their section commanders implicitly, then we shall have nought to fear in June, when we shall be inspected (and inspected thoroughly) by an Army officer.

Extract from War Office letter: "Owing to the exigencies of the military situation it will not be possible to hold the Annual Camp during the current year."

DEBATING SOCIETY.

The second half-session opened with a visibly diminished attendance, but it was characterized by the increased boldness and confidence of some junior members of the House. In spite of a general reluctance on the part of the Sixth Form to take part in the debates, we have held some fairly successful

meetings, although great persuasion was required before the places of the first speakers were filled.

On January 30th, before a meagre House, F. R. Burston discountenanced the idea that conscription was necessary in England, and even went so far as to declare it detrimental to the true interests of the country. Great stress was laid upon the freedom of Englishmen, and the horrible results of its encroachment, but no thought was given to the possibility of the subjection of England as a result of inadequate military preparations. Mr. Lovell added to the arguments of Burston, and appealed to the patriotic instinct by boldly declaring that a volunteer was worth ten pressed men, and that the Englishman derived the initiative which the German lacked from the fact that he was not forced into military training. We see from the minutes that Galloway, Perkins, Wasley, Ryder, Rowley and Jackson openly declared their agreement with the proposer. The opposition, however, led by Mr. Baker, Beynon and Day, successfully criticised the motion, and pointed out that patriotic fervour and bigotry rendered the arguments of the first speaker shallow and groundless. Hoyle, D. and Perry had added further remarks against conscription, the House was appealed to, and the result of the division found the motion lost by ten votes to nine.

On February 13th, before an improved attendance, Bray gave a carefully prepared dissertation on the necessity for compulsory inoculation in the British Army. By means of an astonishing display of statistics he fairly convinced the House, and when Mr. Lovell, Mr. Nicholas, Burston, Wasley, Heath and Attwell had added further weight to his arguments, the opposition was found to consist of Jackson, Ryder, Day, Maund, and one silent member, whose combined efforts were not equal to the task of refuting the statistics and neutralizing their consequences. A division showed the House overwhelming in favour of the motion.

The motion moved at the next meeting, on February 27th, was "That the Censorship of the Press, besides being unnecessary, is undemocratic and detrimental to British interests." Maund opened the debate and deplored the

absence of the records of British reverses in the newspapers, explaining that the result was that the British public were lulled into a false sense of security. Only Wasley, Day and Ryder ventured to support the motion, while the ranks of the opposition were considerably augmented and encouraged by the impressive orations of Mr. Abbott and Beynon. In spite of the active opposition of Burston, Rowley, Bray, Hartin and Perkins, the sound principles of the motion were recognized by the silent portion of the House, and it was carried by one vote.

CHESS CLUB.

The Chess Club met in January and, owing to the enthusiastic organisation of Mr. Orange, has been regularly attended throughout the Term. Wedge, C. N. was re-elected Secretary.

Mr. Allen has frequently honoured us with his presence and interested us with his inexhaustible stock of problems.

Towards the end of February, House matches were begun. Wylde House put a very strong team into the field and meeting School House in the Second Round made a draw. Wedge, W. J. K. and Beynon, A. C. played another game to decide the match. Wedge, W. J. K. lost and thus School House met Tudor House in the Final; but since the latter had lost their Captain it is not surprising School House was victorious.
