# EARLY HISTORY OF THE SCHOOL. IX. (Concluding Article).

## THE USHER.

There shall be an Usher, some man virtuous in living and well-lettered, that shall teach under the Master as the High Master shall appoint him, some single man or wedded.

This Usher shall be chosen by the Rulers, Governors and Supervisors before mentioned, with the advice of the High Master, as often as the room shall be void, a man whole in body and of learning fit for that room, which shall before the said Rulers and Schoolmaster be appointed what he shall do in his office, the Schoolmaster saying unto him in this wise—

Sir, before these my masters here, the Rulers of this School, I shew unto you that they have chosen you to be Undermaster of this School, and to teach alway from time to time as I shall appoint you, and supply my room in my absence when it be granted me by my masters the Rulers, Governors and Supervisors, and for such more labour in my absence I shall somewhat see to you as my masters here shall think best.

Then the Rulers shall exhort that Usher diligently to do his duty, and shall say unto him in this wise—

Your room is no perpetuity, but according to your labour and diligence ye shall continue, otherwise found not according and reasonably warned by us, ye shall depart; if it be so that at any time ye will depart of your own mind, ye shall give us an half year warning.

If any controversy be betwixt you and the High Master, ye shall stand at our direction in anything.

If he will promise this, then let the Rulers appoint the Usher and assign him his lodging, if any be, and to have such wages as shall be appointed him by the said Rulers, Governors and Supervisors.

## A BOOK OF REGISTER TO BE KEPT FOR THE INCOME OF ALL THE SCHOLARS.

Also that every scholar at his income shall pay four pence towards the reparations of the School and other defence of the same, as shall seem good by the Governors thereof, for the avoiding the danger of fire.

## ORDERS TO BE KEPT IN THE SCHOOL.

The scholars shall come to the School at vi of the clock, and shall go to dinner at xj, and come again at xij of the clock, and so continue to five.

Also the Schoolmaster shall every Wednesday and Friday at ix of the clock go to their parish church with his scholars before him in order, and if there be no service at that time then he to read a chapter, and at the departing out of the church to sing a psalm with all the children and scholars, such one as shall seem to him best for that time, praying for the Queen's Majesty and all other founders that giveth either money or lands to the maintenance thereof.

This is the concluding article of the series begun in the December 1013 number. These articles have been abstracted from the late Mr. Arthur F. Leach's large quarto volume on the History of Worcester Schools. Mr. A. F. Leach was a Charity Commissioner and one of the leading authorities in England on the history of schools, and will be remembered as the seconder of the motion for The Prosperity of the School at the opening of the Perrins' Hall in 1915. We regret to have to record his death, which occurred later in the same year. Much of the abstracting for later articles in the Magazine was done by the late Mr. J. E. R. Allen.



# OFFICERS' TRAINING CORPS.

This Term's work has been mainly a preparation for the Annual Inspection. We have also tried the new balanced step, which we hope to elaborate next year.



On Empire Day the Corps took part in the celebration on Pitchcroft, when the Mayor (Alderman A. Carlton) addressed the assembled school children of Worcester. On the following Sunday, a Church Parade was attended at the Cathedral.

On June 22nd, cadets took part in an interesting ceremony on Pitchcroft. A Ceremonial Parade was held by Brigadier-General E. A. W. S. Grove, and five medals were presented to surviving relatives of fallen soldiers. All Worcester troops were represented. After the presentation there was a "March Past" in column. Cadets are to be congratulated upon their steadiness on this occasion. On Saturday, July 7th, the Corps was inspected by Lieut.-Col. C. E. Greenway (commanding troops at Norton Barracks). After a "General Salute," the clothing, equipment and arms of the cadets were inspected, and the "March Past" followed. At the conclusion of the "March Past" we were tested with a surprise order, that the enemy were advancing upon us over Merriman's Hill. The extensions were done very smartly by cadets, and the N.C.O.'s took charge of their sections in a creditable manner. We advanced to the attack by sectional rushes ; the supports reinforced the firing line, and the conclusion came with a rousing charge.

The Company then fell in with the drum for Company Drill, under its various officers. Company-Sergt.-Major G. W. Morrall and Quartermaster-Sergt. C. R. Heath handled the company in a very cool and satisfactory manner. While this was in progress the signallers were being tested. The recruits were put through their squad drill by Lance-Corpl. S. C. Ryder.

In his address to the Corps, the Inspecting Officer expressed himself well pleased with the keenness displayed upon parade. The turn-out was excellent, and the arms were clean. He emphasised the importance of "esprit de corps" in the regiment as in the school, and reminded those cadets who would be taking up commissions of the traditions they had to uphold. He asked them to remember the example of Bandmaster Mackie's family, which had been connected with the Worcestershire Regiment for three generations. An inspection of stores, range, and armoury followed : all kit had been cleaned and laid out in the lockers. The Inspecting Officer was well satisfied with this evidence of keenness on the part of cadets.

On Sunday, July 8th, a Church Parade was held at St. Nicholas' Church.

A visit was paid by 23 senior cadets to the open range at Tiddesley Wood. A motor omnibus was chartered, and a very agreable day was spent. As a result, seven cadets passed Part I. of the general musketry course, Wheal C. W. W. having the highest score. Competition for the House Shooting Shield will be held during the last week of Term.

# BOXING.

The Boxing Competition held at the end of last Term proved very successful. Mr. H. G. Payne, who is now in the Royal Engineers, took instruction classes three nights a week. As these classes were attended by many boys, there was a larger number of entries than usual, and the standard of the boxing was much higher than in previous years. Every house was well represented, and the Inter-house Competition was very keen. In the lightweights Maund, although handicapped by boxing bigger opponents, fought pluckily, but was beaten before the final round. Wells S. and Watkins fought in the final round, and an interesting bout ensued. Wells S., although having the advantage in reach, height and weight, had a hard fight to beat his speedier and more skilful opponent.

The middle-weights provided some very interesting bouts. In the semi-final round Moore boxed Wheal, and Frost, Dovey. Attwell beat G. N. Armstrong after three very close games, while G. W. Morrall had an easy victory over M. B. Matheson. G. W. Morrall met C. G. Attwell next, and beat him, while C. K. Lee beat K. H. Perkins after two very fast and even games. In the final round, C. K. Lee met G. W. Morrall, whom he beat, thereby winning the Fives Cup.

In the Junior Competition, the winners of the first round were J. A. Sinclair, A. W. Kirkaldy, S. Wells, and E. Simson. A stiff contest took place between Kirkaldy and Wells; in the end the former won. In the final round, Kirkaldy met Sinclair, who had easily beaten Simson. An excellent match took place, resulting in a win for Kirkaldy. It is hoped that victors and vanquished alike will continue to take an active interest in the game of Fives, which, besides developing the physique of the player, cultivates agility and precision. We hope for a record number of entries next Spring Term.
